This annual President's letter is meant to review highlights of the past fiscal year and anticipated events in the future. We have moved forward with some significant achievements. We both got and gave.

The Class of 1960 was the winner of the Class of 1945 P-rade Trophy given at Reunions 2011 for the most enterprising P-rade entry during Reunions 2010, our 50<sup>th</sup>. This Trophy commemorated Bob Tellander's idea of the unique and original Kodo drummer float which was the centerpiece of our reunion parade orchestrated by Reunion Co-chairs, Evan Bush and Roger Barth. That award was followed by our Class winning the Ricardo A. Mestres Memorial Annual Giving Award from the Annual Giving Office for having achieved a greater than 80% participation and an annual giving record dollar amount for our Class in connection with our 50<sup>th</sup> reunion. Rich McGlynn, our current Co-Agent, accepted the Award during Alumni Day festivities in February 2011.

But we also gave. We established a new reunion trophy known as the Class of 1960 Quenby Cullen Williamson Reunion Award to be given to the Class wearing the most imaginative reunion costume. Judging was conducted during this past reunion with the first winning class yet to be announced. This trophy is a silver tray with a '60 Janus tiger imprinted on it given in honor of Peter Williamson's wife who was the inspiration behind our distinctive reunion jacket created for our 30<sup>th</sup> reunion and continuously used thereafter.

Events in the future will be the Princeton-Yale football game on November 12, 2011 where we intend to have lunch tables for our Class at Jadwin Gym before the game and a cocktail party at Terrace Club in conjunction with '59 after the game. Our annual dinner with '61 will probably be in March. Our 52<sup>nd</sup> reunion will be May 31-June 3, 2012. This is one of the few times that there is no conflict with Memorial Day weekend which occurs the previous weekend. Hopefully then more of our Class will not have any conflicts and be able to attend both the P-rade and the Class lunch that Evan Bush organizes at the Nassau Club. We had a group of twenty three this year.

I mentioned in my letter last year that your Class Officers wanted to promote more mini-reunions. We have already had them in Chicago and Seattle with great success. One is now being planned in Los Angeles in late winter/early spring of 2012. Increased funding is badly needed to keep up with the increased costs of this program which is effectively monitored by our classmate, Harry Lord. So please send in your Dues card promptly.
